Investigation, disclosure to RTX or other parties (if applicable) and corrective and/or preventive actions

- 6.7 All Enjet Aero Newington, Inc. employees are trained regarding the requirements of this procedure and the RTX Supplier Code of Conduct. Newly hired employees are trained as part of employee orientation.
- 6.8 All new employees are required to complete form 5.0-5 (Disclosure form). On this form employees disclose any conflicts of interest (if applicable) or relationships with RTX employees in a decision making capacity directly affecting Enjet Aero Newington, Inc. (if Applicable).
- 6.9 Enjet Aero Newington, Inc. flows down the requirements of the RTX Supplier Code of Conduct to suppliers whose products or services will be incorporated into RTX purchase orders.
- 6.10 A copy of the RTX Supplier Code of Conduct is posted in the break room along with copies of form 5.0-4 (Report of a Business Concern) and a copy of the Business Ethics Policy. This procedure is contained within the Enjet Aero Newington, Inc. QMS and is available to read by any employee.
